When scheduling, please provide:

- Appointment or pick-up time
- Pick-up address
- Drop-off address
- Return ride needed?
- Will someone assist you in/out of the vehicle or at your appointment?
- Do you need door-to-door service?
- Do you need to use the lift?

— The bus will arrive during the time **window** provided when your ride is confirmed. Please be ready to board.

Cancellations & No Shows

- All cancellations must be phoned in.
- Failure to call = **NO SHOW**.
- Repeated no shows may result in suspension or termination of service.

Rider Guidelines

- Drivers cannot make unscheduled stops. Call the office about changes.
- Drivers cannot enter facilities to find passengers.
- Always use handrails when boarding or exiting.
- Seatbelts must be worn. Remain seated during the trip.
- Service animals are welcome.
- Be courteous to the driver and fellow passengers.
- No eating or drinking on the bus.
- Dispose of trash properly.
- Limit carry-ons to 2 grocery-sized bags.
- Possession of dangerous or unauthorized items (explosives, firearms, knives, etc.) is strictly forbidden.

NEICAC-EARL PUBLIC TRANSIT RESERVES THE RIGHT TO REFUSE SERVICE TO ANYONE WHO CONDUCTS THEMSELVES IN A MANNER WHICH IS DEEMED DANGEROUS, DISRUPTIVE OR MAY OTHERWISE IMPOSE CONCERNS FOR THE SAFETY OF PASSENGERS, TRANSIT EMPLOYEES, OR THE VEHICLE.

Fares

 In-town: \$3.50 one way (Available in Cresco, Decorah, Elkader, Guttenberg, Oelwein, Waukon, West Union)

• Out-of-town trips: \$2.25 per mile

Payment is due at the time of service.
